- Report was presented by Shelly Fredericks (Bus. Mngr.) and reviewed by the Board (See attached).
- Board discussed various issues in the report related to: (1) Budget issues [I.e. The State's ADM appropriations appear to reflect an average 3% increase over 2012-13 school year allocations, while Central Dauphin's increase is approximately 1.6%. After re-calculating student membership for the 2013-14 school year, we are projecting a \$17,000 increase over last year's revenues.] (2) Insurance issues [I.e. After extensive discussion it was decided to maintain our present fiscal premium payment schedule with Cincinnati Insurance for our medical coverage.]
- In addition, action was taken (see motion #2) to approve all Non-contracted employees pay rate for the 2013-14 school.
- Further, action was taken (see motion #3) to disperse 2013-14 Staff retention bonuses in the second pay period, with the exception of Cindy Walker, the latter of whom would receive said bonus upon her return from medical leave.
- Further, action was taken (see motion #4) to approve a 1% pay raise, across the board, for all staff, for the 2013-14 school.
