# Title I Program

- **What is Title I?**
  - Funds to provide programs to help children who are struggling with reading and/or math
  - Extra help (in addition to what they learn during math and/or reading time in the classroom)
  - Funding provided under the Every Student Succeeds Act (ESSA)
- **Types of Programs:**
  - Schoolwide - all students
  - Targeted - students identified for the program based on performance on assessments

# Title I Funds in Our School

- ***Amount of funds available this year: \$51,070***
- Federal funding is used to pay staff, purchase academic resources, host parent meetings, and provide training to teachers.

- **Spelling (K-5):**
  - *Words Their Way*
- **Theme:**
  - Standards based, locally designed integrated science and social studies curriculum

# Title I Assessments

- Assessments are used to help teachers determine if a student is understanding the content presented in the classroom.
  
- We use the following assessments for all of our students:
  - i-Ready Diagnostic Assessment (K-8)
  - Dynamic Indicators of Basic Early Literacy Skills - DIBELS (K-5)
  - Acadience Math Assessment (K-5)
  - Pennsylvania System of School Assessment - PSSA (3-8)



# Proficiency Levels

- If a child does not reach a certain proficiency level when they take an assessment, we consider them for additional help from our Title I program.
- The proficiency levels for our assessments are:
  - ***i-Ready Diagnostic Assessment (K-8)*** - Score on grade level
  - ***Dynamic Indicators of Basic Early Literacy Skills - DIBELS (K-5)*** - Score at benchmark level (composite score)
  - ***Acadience Math Assessment (K-5)*** - Score at benchmark level (composite score)
  - ***Pennsylvania System of School Assessment - PSSA (3-8)*** - Score of proficient

# PSSA Proficiency Levels

- Your child will be taking the Pennsylvania System of School Assessment (PSSA) in grades 3-8.
  - Four proficiency levels for the PSSA:
    - Advanced
    - Proficient
    - Basic
    - Below Basic
  - Our goal (and the state's goal) is for your student to reach the “Proficient” level on the PSSA.

# Assessment Results

- You will be notified of your child's assessment results.
  
- **Timeline:**
  - **PSSA:** Fall after the test is taken
  - ***i-Ready Diagnostic***: First parent-teacher conference
  - ***Acadience***: First parent-teacher conference
  - ***DIBELS***: First parent-teacher conference

- Request Teacher Qualifications
- Notification of placement with non-appropriately state certified teachers for four or more weeks
- Request opportunities to meet regularly with staff for family/parent engagement
- Participate in decisions affecting your child
- Review application for Title I and make suggestions
